Her research interests span the fields of law and religion, comparative constitutional law, and human rights, and her work focuses on the interaction of law, religion, and politics in plural and divided societies. Dian is the author of <i>Constitutions, Religion and Politics in Asia: Indonesia, Malaysia and Sri Lanka</i> (CUP 2017) and the co-editor of a volume on <i>Law and Society in Malaysia: Pluralism, Religion and Ethnicity</i> (Routledge 2018). She has also published in the <i>International Journal of Constitutional Law (I-CON)</i>, <i>Oxford Journal of Law and Religion</i>, and the <i>Indonesian Journal of International and Comparative Law</i>. She serves as the Deputy Editor of the <i>Asian Journal of Comparative Law (AsJCL)</i> and the Editor of the AsJCL's Special Issue on 'Religion and Constitutional Practices in Asia' (forthcoming, December 2018).</p>

He obtained his Juris Doctor degree (2009; cum laude) from the University of the Philippines College of Law, where he was a professorial lecturer (2012-2013; subjects taught: legal history, legal theory, administrative law, and legal research). He is a member of the Integrated Bar of the Philippines. He was an editor of the <i>Yale Journal of Law & the Humanities</i> and the <i>Philippine Law Journal</i>. He is a regional adviser for the <i>Max Planck Encyclopedia of Comparative Constitutional Law</i>.</p> <p>Mr Gautam Bhatia</p> <p>Gautam Bhatia is reading for the D.Phil in Law at the University of Oxford. He graduated from the National Law School of India University (BA LLB, 2011), Oxford (BCL '12, M.Phil '13) and the Yale Law School (LLM '14).
