Name of Panellists	<p><b>Ms Trang (Mae) Nguyen</b></p> <p>Trang (Mae) Nguyen is affiliated with New York University School of Law U.S.-Asia Law Institute and is a visiting scholar at UC Berkeley School of Law. Her research focuses on comparative Vietnamese and Chinese legal systems, including Vietnam and China's local experiments, criminal justice and procedures, land and maritime border negotiations, and environmental litigation. Ms. Nguyen earned a J.D. degree from NYU School of Law and is fluent in Vietnamese.</p> <p><b>Assoc Prof Dr. Jedidiah Kroncke</b></p> <p>Jedidiah Kroncke is an associate professor of law at the University of Hong Kong, joining the faculty in August of 2018. He currently teaches property, equity and trusts, as well as courses in common law reasoning for civil law students. Previously, he was a professor at FGV Sao Paulo School of Law, and before this he was the Senior Fellow at the East Asian Legal Studies Program at Harvard Law School. Dr. Kroncke garnered a range of awards and fellowships as he earned a B.A. in Asian Studies and Legal Studies from the University of California Berkeley, a J.D. from Yale Law School, and a Ph.D. in Social and Cultural Anthropology also from the University of California, Berkeley. After graduate school, he was awarded the Oscar M. Ruebhausen Fellowship at Yale Law School, the Samuel I. Golieb Fellowship in Legal History at NYU Law and the Berger-Howe Fellowship in Legal History at Harvard Law School. He has been a visitor at the International University College of Turin and the National University of Singapore.</p> <p><b>Prof Jacques deLisle</b></p> <p>Jacques deLisle is Stephen A. Cozen Professor of Law and Professor of Political Science at the University of Pennsylvania, where he also serves as the Director of the Center for East Asian Studies and Deputy Director of the Center for the Study of Contemporary China. He is the Director of the Asia Program at the Foreign Policy Research Institute. His scholarship, which has appeared in many international affairs journals and law reviews, focuses on domestic legal and legal-institutional reform, the relationship of legal development to economic and political change, and the roles of law in addressing crises in China; the PRC's engagement with the international legal order; and Taiwan's international status and cross-Strait relations, and. He is the co-editor of <i>China's Global Engagement: Cooperation, Competition, and Influence in the 21st Century</i> (2017), <i>The Internet, Social Media, and a Changing China</i> (2017), and <i>China's Challenges: The Road Ahead</i> (2014).</p>
