Panel Convenor	<p>Prof Alison Duxbury</p> <p>Alison Duxbury is a Professor at Melbourne Law School, University of Melbourne. She is a member of the Council of the Australian and New Zealand Society of International Law, the Executive Council of the Asian Society of International Law, and the International Advisory Commission of the Commonwealth Human Rights Initiative. Alison's major teaching and research interests are in the fields of international law, international institutional law, human rights law and public law. She has been a Visiting Fellow at the Lauterpacht Centre for International Law in Cambridge, the Centre for Comparative and Public Law at the University of Hong Kong, the Oxford Institute for Ethics, Law and Armed Conflict and the Institute of Commonwealth Studies in London. Alison's publications include <i>The Participation of States in International Organisations: The Role of Human Rights and Democracy</i> (Cambridge University Press, 2011), a co-edited collection, <i>Military Justice in the Modern Age</i> (Cambridge University Press, 2016), and a forthcoming co-authored book (with Dr Tan Hsien-Li), <i>Can ASEAN Take Human Rights Seriously?</i>, to be published as part of the ASEAN Integration Through Law Project.</p>
Name of Panellists	<p>Dr Tan Hsien-Li</p> <p>Tan Hsien-Li is the Co-Director (Teaching) for the ASEAN Law and Policy Programme at the Centre for International Law (CIL), NUS. She was previously Senior Research Fellow and Executive Director of the ASEAN Integration through Law Project at the CIL. Dr Tan has held fellowships at the European University Institute, Florence, and the Jean Monnet Center for International and Regional Economic Law and Justice, NYU School of Law. She was also the AsianSIL Research Fellow at the NUS School of Law and the Ushiba Memorial ASEAN Fellow in Tokyo. Dr Tan researches on the role and the rule of law and institutions in ASEAN Integration; public international law, particularly on institution building and norm creation; and human rights and peace and security. She wrote the first book on the ASEAN human rights system (Cambridge University Press 2011) and has co-authored a book on ASEAN dispute settlement mechanisms (Cambridge University Press, 2016). She is currently working on two more books—the documentary analysis of ASEAN instruments and a theory of the ASEAN Way. Dr Tan is an editor of the <i>Asian Journal of International Law</i> and the general co-editor (together with Professor Joseph Weiler) of the ASEAN Integration Through Law Book Series (Cambridge University Press).</p> <p>Assoc Prof Catherine Renshaw</p> <p>Catherine Renshaw is Deputy Head of the Thomas More Law School at Australian Catholic University. She received her law degree from the University of New South Wales and her Master of Laws and Doctor of Philosophy from the University of Sydney. She has a degree in Arts (History major, Hons) from the University of Sydney. Her research focuses on human rights and democracy in Southeast Asia and she has recently carried out fieldwork in Myanmar and Thailand. She is admitted to practice as a lawyer in the Supreme Court of New South Wales and the High Court of Australia.</p> <p>Prof Yuyun Wahyuningrum</p> <p>Yuyun Wahyuningrum is currently the Representative of Indonesia to the ASEAN Intergovernmental Commission on Human Rights (AICHR), 2019-2021. She is also a PhD candidate at the International Institute for Social Studies (ISS) in The Hague of the Erasmus University. Her research deals with global-regional interaction of the human rights norms with specific focus on ASEAN as a site of contestation and the role of the participating actors. She has spent more than twenty years working in different NGOs, which half of it was dedicated to engage with ASEAN's advocacy, especially on the area of ASEAN Political-Security and Socio-Cultural Pillars.</p>
